

District 5010 Rules for Inbound Students

In consideration of the opportunity afforded to me by Rotary International District 5010 and my sponsoring Rotary Club to be an international exchange student for one year, I agree to or acknowledge the following:

1. I will devote whatever time is necessary to learn the essentials of English before departure for Alaska/Yukon.
2. This is a student exchange; I will attend classes.
3. I understand that this is not a travel exchange. My host parents and host Rotary Club must explicitly approve all travel outside the host community. All travel outside the host Rotary District must be approved by the District and my parents.
4. **I will not smoke.
I will not use illegal drugs.
I will not drink alcoholic beverages in violation of Alaska or Canadian law.
I will not drive a motor vehicle of any kind.
I will not seriously date one person as to become romantically involved and will abstain from sexual intercourse or activity.**
5. **I will obey the laws of the host community and country and conduct myself in a manner to reflect credit to myself, my family, and my country.**
6. I will participate in all Rotary meetings and functions as required by the Youth Exchange Officer of my Rotary Club or District.
7. I will attend classes and do my best to complete all of my classwork with passing grades.
8. I will bring with me an emergency fund of U.S. \$500.00, which will be deposited into a controlled account immediately upon arrival. This account will require the signatures of the YEO and student for withdrawals.
9. All expenses other than school-related are my personal responsibility, such as postage, clothes, telephone, etc.
10. I will write home at least once a month.
11. I will report to my sponsoring Rotary Club in writing at least once every two months.
12. All travel to and from my host country must be in confirmed reservations status only, and not standby. All tickets must be full-fare, with an open return date, valid for one year.
13. I will obtain a multiple entry visa for both the U.S. and Canada, if hosted by Southeast Alaska or Canada.
14. I will ensure that I have all of the proper immunizations that are required by the school district that I will attend.
15. I will complete my exchange and fulfill all the requirements of the host Rotary District and Club.
16. I understand that violation of any of the above rules may result in my being eliminated from the program at any time prior to my departure or may result in early return.
17. **I will make every effort to get involved with my host family, school, and host club knowing that my efforts will make for a successful exchange.**
18. **Upon completion of my exchange I will return to my own country by the most direct available route with no stops other than required by the airlines.**

Parents : Exchange students will participate in Youth Exchange activities where they may be photographed or videotaped.
